

## STATEMENT

With the text under, I \_\_\_\_\_ (lower signed) , as a member of Croatian airsoft federation (in further text: HASS) and participant of the airsoft meetings and events in organization of HASS members, confirm that I am fully acquainted with the Rules of the Croatian airsoft federation (in further text: Rules) and fully commit that I will comply with them while attending meetings and events organized by HASS members.

I particularly contend that I am conscious of the need to wear protective equipment (primarily safety eyeglasses) in a proper way for this purpose, and that it is allowed to remove it only in the places specified by the organizer.

I am aware that even in such places I may get injured or my equipment can be damaged by the actions of other participants of the meeting and events, and if they do, I claim that I will not charge the organizer for the same.

If such places do not exist, I am aware that I act contrary to the Rules if I remove my eyeglasses or any other part of the protective equipment before the official end of meetings and events.

I am aware that meetings and events officially start and finish at the moment when it is declared by the meetings and events organizer).

I am aware of the fact that there is a possibility of injury in the area where airsoft meetings or events occur, since it is either a forest or a ruined building and/or rocks, so I willingly and without a persuasion agree to participate in meetings and events, regarding to the terrain where they are held.

I am aware that due to the nature of the same terrain, as well as the realism of every airsoft meeting and event, and the limitations imposed by the owner of the terrain, the meeting and event organizer is unable to place appropriate warnings and remove dangerous items so I agree to all, with the associated risks, regardingly the possibility of injury and damage of my property as a result of the terrain configuration and caused by objects in the same space.

I am aware that the organizer of the meeting or event is not in a position to protect the property I use at the meeting or event, which includes protection of a vehicle with which I came to the event, damage and theft of my equipment, and if so, for the compensation of damage I will charge only the pest. I am especially aware that I will not destroy entrusted props and that, in the case of intended damage, I will pay the amount defined by the organizer of the meeting or event.

Especially, I am aware that my participation in an airsoft meeting or event can cause injuries to all parts of my body and to the equipment I use as well, because of the hits of the plastic balls fired from airsoft replicas. I am also aware that described hits from airsoft replicas to my body and the equipment that I use are an inevitable part of any airsoft meeting or event and I am ready to take all of the risks that come from it and will not consider organizers of the same meeting or the event responsible.

For the described injuries and damage that may occur, I will not consider any other attendees of the airsoft meeting or the event responsible, if they act according to the rules when firing plastic balls from the airsoft replica that they use and which hit any part of my body or the equipment that I use.

I am aware of all the efforts with which the organizer keeps the airsoft meeting or the event in accordance with the Rules and in a sporting spirit, respecting fair play, and will do everything in my power to personally contribute to the benefit of the event.
